Dear Judge Schofield:

By letter motion dated January 26, 2017, Plaintiffs in the above-captioned matter moved for an adjournment of the February 1, 2017 date to begin the process of disseminating the Mail Notice and Claim Form as established by the Court's Order of December 20, 2016 (ECF No. 700). By order dated January 27, 2017, the Court ordered that the time to initiate notice be adjourned *sine die* (ECF No. 719). The Court further ordered that Plaintiffs provide a status update by March 31, 2017 (ECF No. 734), May 1, 2017 (ECF No. 748), and June 1, 2017 (ECF No. 759). The Court further ordered that Plaintiffs propose the following timeline for notice by June 1, 2017. ECF No. 759.

By July 28, 2017, Plaintiffs will move for preliminary approval over new settlements and for approval of an updated notice and plan of distribution covering both the original nine settlements and the new settlements. In those papers, Plaintiffs anticipate proposing the following timeline for notice:

Publication of Summary Notice: date by which publication of Summary Notice shall begin	As soon as practicable after Notice Date
Settlement Website: date by which Mail Notice and Summary Notice shall be published on Settlement Website	On or before Notice Date
Final Approval and Fee Briefs: deadline for filing of papers in support of final approval of Settlement Agreements and Class Counsel's application for attorneys' fees and expenses	January 12, 2018
